A 12-Step Program for Recovering from Mormonism

 $T_{ extit{HOUSANDS}}$ of people suffering from the devastation of alcoholism have been helped by following the "Twelve Steps" developed by Alcoholics Anonymous. Many other programs dealing with from drug addiction, recovery addictive overeating, and other behaviors have adapted AA's Twelve Steps. Those leaving Mormonism usually are dealing with similar problems of recovery, and the following is an adaptation of the Twelve Steps for help in recovering from Mormonism.

- 1. I admit that I am powerless to change the fact that I have been Mormon for a good part of my life, whether because I was born to Mormon parents, or because I voluntarily converted.
- 2. I realize that I have within me the power to free myself from the harmful part of my Mormon past (with the help of a higher power if I believe in one), and that I am no longer bound by promises or covenants which I was induced to make based on the false promises of Mormonism.

- 3. I make to myself a firm promise to listen in the future only to reason, rationality, and factual evidence in making decisions about how I should live my life, rejecting all emotional appeals, guilt-inducing threats, myths, pretty stories, promises of castles in the air, and superstition.
- 4. I make a searching and fearless moral and intellectual inventory of myself with the purpose of recognizing in myself those weaknesses which induced me to remain Mormon for so long.
- 5. I itemize (preferably in writing) to myself and to a trusted loved one (and to a higher power if I believe in one) the specific reasons why I can no longer be Mormon.
- 6. I make the decision to do what is right, and to accept whatever the consequences may be for acknowledging the truth and living accordingly.
- 7. I begin working through each of my Mormonism-related problems of mind, body, relationships, and (if I believe in such a thing) spirit.

- 8. I make a list of those for whom it would be important to know of my decision and the changes I am making in my life, and prepare myself emotionally to discuss my decision with them all, realizing that many may react with hurt, anger, emotional outbursts, or other unpleasantness.
- 9. I discuss my decision with them (except in those cases where I think it would cause greater harm to do so than not) in a calm, friendly and loving way, without argument.
- 10. I continue to take personal inventory, and where I find artifacts of Mormonism, I carefully consider whether they should continue to be a part of my life, or whether I should discard them.
- 11. I seek out truth wherever I can find it, whether religious or secular.
- 12. Having had an awakening and renewal as the result of these steps, I try to be helpful to other recovering or doubting Mormons, and to practice these principles in all of my affairs.

Mixed Reviews for September Dawn

The long-anticipated movie based on the Mountain Meadows Massacre, September Dawn, has met with mixed reviews. Roger Ebert awarded it a thumbs down, and Entertainment Weekly called it "...a plodding and highly questionable history lesson." The Boston Globe said, "...it only serves to remind us of one of the uglier chapters in American history."

On the other hand, MatchFlick gave it five stars, and Maxim's Peter Hammond said, "Despite awkward direction by Christopher Cain and uneven story-telling, September Dawn is often gripping and fascinating, packing a powerful punch particularly in later scenes as the tension escalates."

Perhaps the Seattle Times reviewer put it best: "September Dawn is well-crafted as a revisionist Western with a message. If the message is muddled, there's plenty of literature to clear the facts — or to make the matter even more bewildering for those seeking truth.

DVD Project Nears Completion

Work on a DVD featuring a number of well-known ex-Mormons explaining why they left the church, is nearing completion. The DVD, commissioned by the Exmormon Foundation, is still unnamed as we go to press, but is expected to be completed in time for a showing at the October conference in Salt Lake City.

Among those interviewed in the DVD Simon Southerton, DNA are Ken Clark, former researcher: CES employee; Bob McCue. attorney; Arza Evans. professor, Bill Gardiner, clinical social worker; Tal Bachman, professional musician; Tracy Bachman, English convert; Richard Packham. retired teacher and attorney; Jarom Smith, former missionary; Dennis Farley, author and attorney; and Sandy Crain, president of the Exmormon Foundation. Several of the participants have served as bishops or held other positions of authority in the Church prior to their resignation.

When completed, the DVD will be available for purchase on the Exmormon website.
